Jan Van Sickle

Geodesist & Principal Scientist R&D at Maxar

Biography:

Jan Van Sickle is currently a Geodesist and Principal Scientist R&D at Maxar (formerly Digital Globe). He has many years of experience in GIS, GNSS, surveying and mapping. He began working with GPS in the early 1980s when he supervised control work using the Macrometer, the first commercial GPS receiver. He created and led the GIS department at Qwest Communications for the company's 25,000-mile worldwide fiber optic network. He also led the team that built the GIS for natural gas gathering in the Barnett Shale. He assisted the supervision of the first GPS control survey of the Grand Canyon. He led the team that collected, processed and reported ground control positions for more than 120 cities around the world for the ortho-rectification of satellite imagery now utilized in a global web utility. He managed control for the BIM of the White House and the creation of the worldwide T&E sites for two major earth observation satellites (Geoeye I and Geoeye II). He conducted a spatial accuracy comparison study for Maxar in Durban, South Africa, Seoul, South Korea and Rio De Janeiro, Brazil. He has provided technical assistance in the reconstruction of the geodetic network of Nigeria. He has managed the gravity/magnetic and hyperspectral/multispectral analysis of Borzon VII a concession block in the South Gobi in Mongolia. He created an imagerybased system of deriving road centerlines that meet the stringent Advanced Driver Assistance specifications and developed a method of forest inventory to help quantify that depleted resource in Armenia. He has led nationwide seminars based on his three books, GPS and GNSS for Land Surveyors, Basic GIS Coordinates and Surveying Solved Problems. He has been a featured speaker at many conferences including GITA conference and the Institute of Navigation (ION) Annual Meeting. He delivered the keynotes at the 2010 ESRI UC in Imagery and Remote Sensing, the 2021 URISA/NSPS keynote and the 50th Texas Society of Professional Surveyors Conference. He was a Senior Lecturer at Penn State University.

Jan earned his Ph.D. in geospatial engineering from the University of Colorado. He is a ASPRS Certified Photogrammetrist and Lidar Mapping Scientist.

AM Seminars

8 am – 9:45 am - Best Practices for GPS/GNSS

Global Positioning System (GPS) is now a part of a growing international context—the Global Navigation Satellite System, GNSS. One definition of GNSS embraces any constellation of satellites providing signals from space that facilitate Positioning, Navigation, and Timing (PNT) on a global scale. Current use of the term typically includes global systems such as the Russian Federation's GLONASS, the Galileo system administered by the European Union (EU), the Chinese Beidou Navigation Satellite System (BDS). It can also include regional systems such as the Indian NavIC System and the Japanese Quasi-Zenith Satellite System (QZSS). In a sense GNSS surveying is GPS surveying because the measurement principles, procedures, and applications originally developed for GPS surveying apply. That is not to say that they remain unchanged. Developments in GNSS hardware, software, and procedures are accelerating. Keeping up is a real challenge. The extraordinary range of GNSS equipment and software requires the user to be familiar with an everexpanding body of knowledge. My hope in offering this seminar is to contribute some small assistance in that process.

10 am - 11:30 am - Coordinates and Reference Frames (Part 1)

Coordinates? Press a few buttons on a computer and they are automatically imported, exported, rotated, translated, collated, annotated and served up in any format you choose with no trouble at all. There really is nothing to it. Why have a seminar about coordinates? It's a good question really. Computers are astounding in their ability to make the mathematics behind coordinate manipulation transparent to the user. This seminar is not much about that sort of mathematics. But it is about coordinates and coordinate systems. It is about understanding how these systems work, and how they sometimes don't work. It is about how points that should be in Rhode Island end up in the middle of the Atlantic Ocean even if the computer has done nothing wrong. And that is, I suppose, the answer to the question from my point of view. Computers are currently very good at repetition and very bad at interpretation. People are usually not so good at repetition. We tend to get bored. But we can be very good indeed at interpretation, that is if we have the information in our heads to understand what we are interpreting. This seminar is about providing some of that sort of information on the subject of coordinates and coordinate systems.

Our software, our tools even the scope of our work is expanding fast. Dynamic reference frames and epochs, DevOps, SLAM, UAS data, Mobile Mapping, NATRF, just to mention a few. We can contribute to all of them, but as the Red Queen said in Alice in Wonderland, "... it takes all the running you can do, to keep in the same place." So, let's help each other do that because we are in this together.

THE HISTORY OF THE RHODE ISLAND SOCIETY OF PROFESSIONAL LAND SURVEYORS



In December, 1970, a small group of land surveyors got together at the Governor

Dyer Restaurant in Providence to start a discussion. Attending the meeting were Ken Anthony, Tony Caputo, Robert Curran and Pierre Guillemette. The discussion centered around the needs of the typical practicing land surveyor. At the top of their list was a need for a means where land surveyors, from all parts of the state could interface with one another and compare common needs for a professional practice. A meeting held at Camille's Roman Garden one month later enlisted the additional help of Armando Gama, Leonard Garofalo, Earl Marsh, Patrick McCormick, and Elson Stanley. These nine people formed the committee to form the "Association of Rhode Island Land Surveyors". This name was changed to the "Rhode Island Society of Professional Land Surveyors" at the first "Official" meeting, held March 30, 1971, at the Governor Dyer Restaurant. Fifty-eight persons attended that first meeting, elected officers and directors, and commented on the current state of affairs of land surveying in Rhode Island.

Issues that brought this Society together are similar to needs currently expressed as important by practicing land surveyors. Foremost was a need for a minimum standard of practice. Up until this time, practicing land surveyors obtained their expertise from many different sources and as a consequence confusion developed as to the "proper" practice of land surveying. Other issues considered were to establish a fair fee schedule, and a concern over the promulgation of the Department of Environmental Management's "Freshwater Wetlands" bill and the Health Department's new regulations for sewage disposal systems.

During 1971, "By-Laws" were prepared and established as a way in which RISPLS would be organized and respond to the land surveyors needs. Throughout the By-Laws, a major concern was the formulation of the need to supply the public with a consistent professional service. The specific purpose of the RISPLS was given in four parts. First was a statement that land surveying was to be recognized as a separate and distinct profession, secondly that RISPLS was to establish and maintain a standard of practice and ethics for protection of the public. The third purpose listed established a commitment to the advancement of our professional, economical and social interests. The fourth and final purpose made it clear that education would play a major role in making the first three goals possible, and recommended scholarships and other incentives to make a formal education in land surveying desirable.

Although a recommended fee schedule was prepared and published in December 1971, a later concern over being seen as "price fixing" caused this effort to conclude. It is interesting to note however, that the hourly professional fee rates published in 1971 are comparatively close to the wages paid to employees in this economy. During the following years, steps were taken to offer the Rhode Island practicing land surveyor services and information that would better prepare those land surveyors to serve the public in a professional and informative manner.

During 1974 and 1975 efforts towards establishing education programs were culminating in starting a night course at Davies Vocational School in Lincoln to train entry-level technician. Continuing education programs became a priority and RISPLS started holding seminars and work sessions on topics that varied from Legal aspects of land surveying to what DEM expected of our services. A night course in practical land surveying, taught by our late Pierre Guillemette, was started at Rhode Island Community College. In 1989, Chariho Vocational School started a program in their curriculum including land surveying and the University of Main at Orono started a "Surveying Engineering" Course, dedicated to land surveying. RISPLS members were a major force in getting these programs started.

More recently, RISPLS has strived to maintain and advance the land surveyors image as a separate and distinct profession by responding to legislation that in 1992 formed a Board of Registration for Land Surveyors comprised of land surveyors. We are now in the process of defining our professional activities in a manner in which that Board may keep a tight rein on land surveying professionals and in doing so develop an atmosphere of permanence to our services that will continue on into the next generation.
